### **Holy Trinity West Hendred Oxford Historic Churches Ride and Stride – 14<sup>th</sup> September**

This year's sponsored event is on Saturday 14<sup>th</sup> September – money raised will be divided equally between The Oxford Historic Churches Trust and Holy Trinity Church. We usually receive our portion in late December or early January.

OHCT suggest "You might like to try one of our newly launched 'suggested routes' – we have walks on offer (including both instructions and a narrative read in advance about the churches included), a chance to follow in Bishop Gavin's 2021 and 2023 rides and a few more cycling routes too."

In June 2023 OHCT very generously awarded a feasibility grant of £1,100 for the entire net cost of a Structural Engineer's inspection and report of the Bell Frame and its supports. In February 2024 OHCT also awarded a grant of £3,000 towards the new heating system, which was installed in May. We are now applying to OHCT for a grant towards major work to re-tile the chancel roof.

### **Sarah James - District Councillor update SESRO Reservoir – can it ever be safe?**

Thames Water have spent the summer carrying out a reservoir options consultation.

Should the access road go here, or here? The intake from the Thames here, here or here?

This implies that the case has been made and accepted that one, huge reservoir in this location is the best way to address water supply for South-East England. But that's not true.

Thames Water put this case in their draft Water Resource Management Plan, but that hasn't been accepted and published by the Government yet. The Environment Agency's

advice to Government is that it shouldn't be published in its current form.

I have responded to the latest Thames Water consultation, continuing to raise my concerns again that this is neither the best solution for the region, nor acceptable as it stands to our community.

One frightening aspect of the plans is the Emergency Discharge plan. The reservoir must be able to empty at a rate of 1m of water depth per day. Those are the safety requirements. From the point of view of anyone living near the reservoir embankment that is likely to feel too slow. If the reservoir is full, it would take 23 days to completely empty it at that rate. But that is still a tremendous rate of water discharge. It is 75 m<sup>3</sup> per second.

This consultation laid out options for the channel or underground tunnel that will carry that water to the Thames in an emergency. It would discharge below Abingdon and above the Culham Cut and Sutton Courtenay. But it doesn't say anything about the ability of the Thames to handle that discharge. The average flow in the Thames below Sutton Courtenay is only 26 m<sup>3</sup> per second. Suddenly adding 75 m<sup>3</sup> per second could be catastrophic: for people in or near the river; for riverbanks and wildlife; and for infrastructure such as locks and bridges. It just isn't safe to build a single reservoir this big in this location.

### **Council encourages people to take part in Thames Water Reservoir public consultation - deadline 28.2.2024**

Vale of White Horse District Council is encouraging its residents to give their views on Thames Water's proposed reservoir for the district.

Thames Water has launched a public consultation on the proposed reservoir and the public have until 28 August to give their views - available here: <https://thames-wrmp.co.uk/sesro>

Plans for the controversial reservoir near Abingdon have again been criticised by local communities, with Vale of White Horse District Council urging water providers to consider alternative solutions more seriously. The reservoir is now even bigger than originally planned - at around 6.5 km<sup>2</sup> – almost as big as Gatwick Airport and unprecedented in scale. The council reaffirmed its objections to the reservoir in a formal letter to Thames Water after the water company submitted its revised Draft Water Resources Management Plan to the government.

The council argues that the plans fail to fully consider the long-term impacts to the local community and the environment, both during a decade of construction and the irreparable damage to the countryside.

Any reservoir would also come at the expense of significant carbon emissions which the council argues would impact the district's ability to become carbon neutral by 2045.

Cllr Bethia Thomas, Leader of Vale of White Horse District Council, said: "With public confidence in Thames Water at rock bottom – and the further news this week on the company's significant financial challenges – it seems remarkable to me that it remains fixated on pushing ahead with this environmentally disastrous plan without properly exploring much more sensible and effective options. We remain opposed to these proposals and want to encourage residents to view the plans and give their feedback to Thames Water as well. "Instead of sinking significant financial and carbon costs into a giant reservoir that dominates our countryside, water suppliers should be fast-tracking less disruptive alternatives by fixing leaks, helping us all to

reduce our water consumption and by exploring the use of water transfers.

"We will be providing our feedback as part of this latest process, and we will continue to represent our residents and urge water providers, regulators and government to listen to local voices and reject these plans."

**NB.** In December 2021, Vale of White Horse District Council agreed a motion to: 'reaffirm its position from the previous public inquiry that it opposes the reservoir proposal unless or until the case for need for this specific solution (over and above the other potential cheaper, less disruptive, and less environmentally impactful solutions) has been clearly tested, demonstrated and agreed by independent scientific experts.'

On 22 December 2023, the council restated its opposition to the Abingdon reservoir: 'the motion noted the council's concerns around the Southeast Strategic Reservoir Option (SESRO) set out in the draft regional plan by Thames Water.'

The council's resolutions included to request a meeting with the Secretary of State alongside a call for the SESRO approval processes to be paused.

### **Holy Trinity Church**

We want everyone, regardless of age or background, to feel able to take part in the life of the church. As a first step, we have refreshed the orders of service that we follow

on Sunday mornings to make the services more welcoming to all who are not used to attending. Why not give it a try?

A hundred years ago, people imagined that with the increase in mechanisation and automation, in the future we would only need to work three hours a day, and machines would do everything else. We've now reached a level of automation that they could only dream of, and yet our work is getting out of hand, not slowing down. We need to have rest prescribed for us. We need the 4th Commandment: remember to keep holy the Sabbath day. Sunday, our Sabbath, is a day to stop and pay attention, to unclench, and to celebrate. If you were here at Christmas, you may recall hearing me speak about the world as a place of convalescence, a place where God is at work to heal us. And I believe the Church is best seen as a hospital, a model for what the world could be: a place for the rehabilitation of recovering broken people, and a place where all are invited to take part in that rest.

Our Sunday services continue at 9:30am on the first, second, and fourth Sunday of each month, and at 6pm on the third Sunday (e.g., 15th September). The afternoon service, Family Church, takes place at St Augustine's East Hendred, 3:30pm every Sunday during school term, starting up again on 8th September.

Do save the date for this year's Harvest service on Sunday 6th October, 9:30am at Holy Trinity: a short Family Service where we will give thanks for the gifts brought to church by children and others. The service will be followed by refreshments.

### **Winter Fuel Payment**

The Winter Fuel Payment has changed and we are urging older people across Oxfordshire to check whether they are entitled to Pension Credit or any other qualifying benefits.

The Winter Fuel Payment is an annual tax-free payment for households that include someone born on or before 23rd September 1958 (for 2024-25) designed to help cover heating costs in winter, with households receiving up to £300.

Previously, the payment was not mean tested, but changes by the current Government mean that only those receiving certain benefits will receive the contribution to heating costs. Pension Credit is the primary way older people can continue to receive the Winter Fuel Payment, and with an estimate of more than 4,000 older people across the county not claiming the Pension Credit to which they're entitled, it's more important than ever that people check their eligibility. Pension Credit is an income-related benefit that tops up weekly income to £218.15 for a single person and to a joint £332.95 for a couple.
