The current fundraising effort is to secure funds for the planning application. Most of the money has been secured with only £15k still to be raised. The aim was to obtain planning permission in 2026. It was suggested that members of the Village Hall committee could give advice on fundraising for the construction phase. 10/26	<p>PLAYING FIELD</p> <p>The inside hedges were awaiting a cut. The playground inspection had been circulated. A loose pole on the new equipment needed to be looked at. Broken fencing needed repair.</p>	Clerk/ME
11/26	<p>PLANNING MATTERS</p> <p>a) P26/V0022/HH – Greenway Cottage, The Greenway. First-floor extension above current double garage to provide master bedroom with en-suite and dressing area, including formation of gabled dormer windows to front and rear, front extension of garage in line with existing porch, partial garage conversion to create WC, snug and utility rooms, rebuilding of front canopy, single-storey rear extension to create dining/garden room with sedum roof and bi-folding doors, replacement windows and external redecoration, installation of rooflights, and associated internal reconfiguration. Response due by 6th February. Cllr Evans abstained from the discussion. It was agreed that a site visit was required and a response would be agreed by email.</p> <p>Proposed Cllr Axel-Berg, Seconded Cllr Pill. It was felt that the Parish Council should be independent and not join forces with other parishes in submitting a response. Concern was expressed over the A417 since a significant amount of construction traffic would use that route. There was no information available about the proposed pipeline to Southern Water.</p>
